## SUBSCRIPTION AGREEMENT

Terms and Conditions Effective Date October 1, 2008

In addition you will be liable for any collection costs incurred by @Communications, Inc. in conjunction with your account, including collection and/or attorney fees.
3. @Communications, Inc. makes no warranties of any kind, whether expressed or implied, including any implied warranty of merchantability and fitness of these services for any particular purpose. @Communications, Inc. takes no responsibility for any damages suffered by you including, but not limited to: loss of data from delays, non-deliveries, missed deliveries, or service interruptions, even if caused by the negligence of @Communications, Inc. or your errors and/or omissions.
